

# Terms and Conditions of Competition Under Promotional Campaign for New Types of Pumps

#### §1. Organiser

1. The competition is organised by MAEM Sp. z o.o. with the registered office at 22a Bociana Street, 31-231 Krakow, Tax Identification Number (NIP): 9452048731, ("Organiser"). The Organiser hereby launches a competition ("Competition") for customers.

#### §2. Entering the Competition

- 1. To qualify to enter the Competition you must:
  - 1.1 Be aged 18 or over;
  - 1.2 Be an employee of the company cooperating with the Organiser.
  - 1.3 The following persons are not eligible to enter the Competition:
    - 1.3a employees of the Competition Organiser;
    - 1.3b persons directly connected with the Competition organisation;
    - 1.3c persons closely related to those organising and running the Competition.

### §3. Competition Schedule

1. You may enter the Competition from 14 January 2019 to 28 February 2019.

### §4. Competition Rules

- 1. You enter the Competition of your own free will.
- 2. By entering the Competition, you agree to be bound by the competition rules.
- 3. Every tenth order for pump products featured in the flyer (Kral, Desmi, Allweiler) and registered in the Organiser's operating system will be rewarded with MAEM promotional gadgets.
- 4. The Competition relates to orders in excess of EUR 100.

### §5. Prize Awarding and Claim

- 1. The guaranteed prize in the Competition shall be a set of MAEM promotional materials.
- 2. There is no cash alternative for the prizes awarded.
- 3. The winner shall specify the address for prize delivery.
- 4. The Organiser shall cover the cost of prize delivery to the winner's registered office according to Incoterms CPT.
- 5. The Organiser shall not be liable for the entrant's failure to claim the prize or any impediments thereto, if the entrant bears responsibility for it.
- 6. If the winner cannot be contacted within 30 days of announcing the competition results, the Organiser shall be released from its obligation to deliver the prize.
- 7. The winners shall be informed of the prizes awarded to them on an individual basis.

# §6. Competition Judges

- 1. The Competition Judges shall have control over the Competition.
- 2. The Judges shall be: Wioletta Bogunia, Justyna Kaczorek.
- 3. The Competition Judges shall, in particular, be responsible for:
  - 3.1 resolving any issues not regulated hereunder;
  - 3.2 awarding prizes.

## §7. Final Provisions

- 1. The Organiser shall have the right to amend the Terms and Conditions at any time over the duration of the Competition.
- 2. These Terms and Conditions are rules of the Competition.

- 4. Any matters not regulated hereunder shall be governed by relevant provisions of the [Polish] Civil Code.
